Temptation Miches will allow singles and have topless areas.

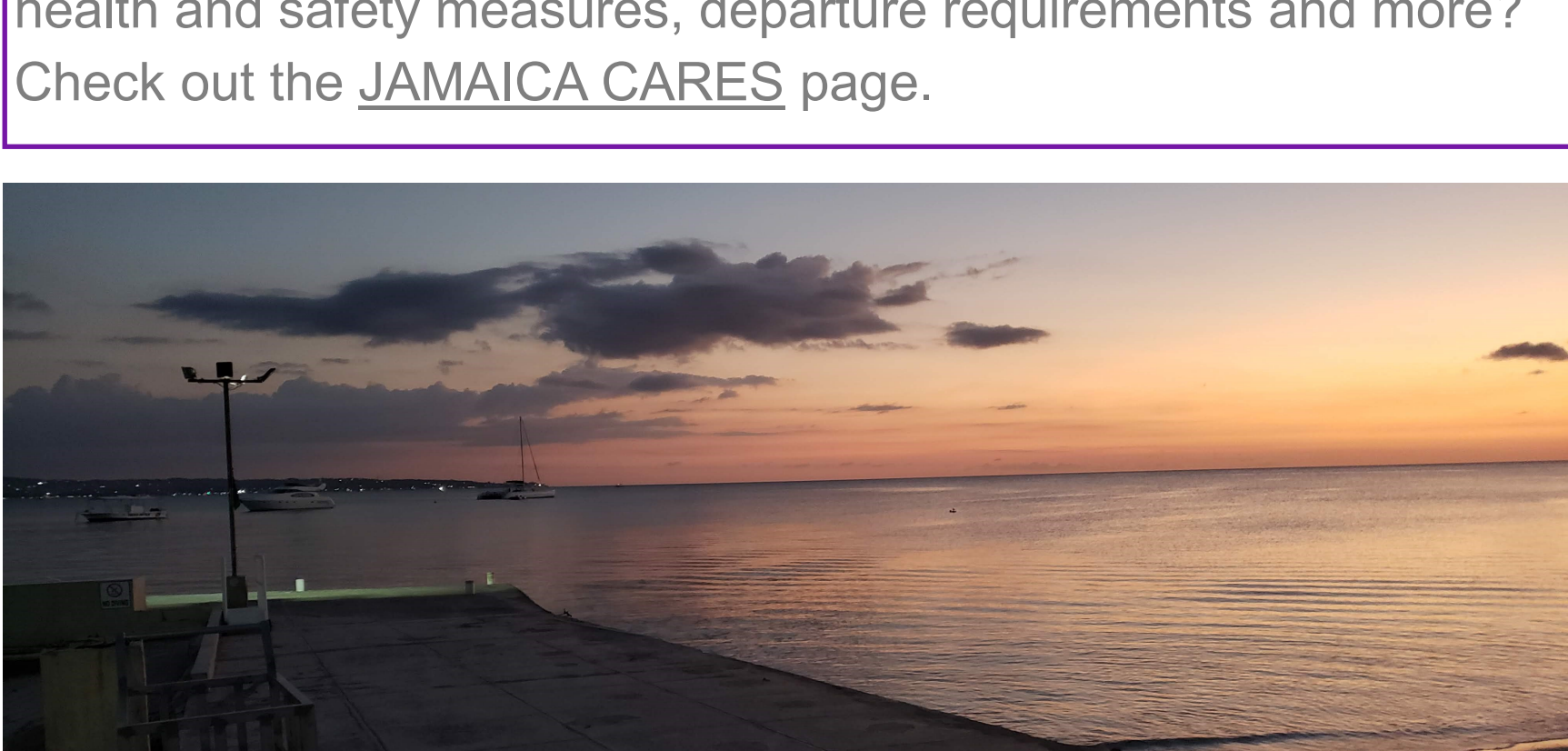
